REGULATIONS

Check or money order must accompany returned application

1. Items must be placed on driveway or curb. Collectors will not enter buildings or collect from porches.
2. Doors must be removed from refrigerators and freezers.
3. Householder will be notified of scheduled collection date.
4. Collection hours are 7:00 a.m. to 3:30 p.m. Monday through Friday. No collections will be made on Saturday, Sunday or holidays.
5. Loose materials must be in sturdy containers. Materials in paper bags or cardboard boxes will not be collected.
6. Demolition, renovation and construction materials must be removed by contractor, and will not be accepted by the Township for disposal.
7. Residents may take refuse or acceptable bulky waste to the Township Transfer Station, 1300 Woodbine Avenue, Penn Valley, during weekdays 8:00 a.m. to 3:30 p.m. and Saturdays 9:00 a.m. to 2:30 p.m.
